# **Summary overview**

This is the first independent annual review of Welsh Gymnastics Safeguarding Key Performance Indicators (KPIs). As such, it marks a significant milestone in ensuring a safe and supportive environment for Welsh Gymnasts, their coaches and families, and the broader gymnastics community.

The review is divided into three sections: this summary overview, a detailed review of the relevant KPIs and suggested KPIs for years two and three.

The indicators were developed in 2023 to help Welsh Gymnastics track its activity to deliver its three-year Safeguarding and Wellbeing Plan. This first year involved setting up the processes and structures to drive the required systematic changes.

#### Assessment

By publishing KPIs, and independently assessing progress against them, Welsh Gymnastics is demonstrating its active and transparent commitment to safeguarding.

# The Pollen Shop

# **Section 2: Detailed Assessment of relevant KPIs**

# **Review of KPIs about Culture and Strategy**

The first two KPIs are responses to self-reported safeguarding questions. These questions are now asked of gymnasts in operational surveys to determine whether they feel safe. At an individual level, a feeling of safety is subjective, and various factors will influence the response to any question about safety.

This KPI has been met, and considerable work has been undertaken to ensure the Board effectively oversees the Safeguarding and Wellbeing Plan, for example:

- The board agreed upon the final version of the Safeguarding and Wellbeing Plan, published in June 2023.
- All board meetings receive appropriate reports on safeguarding.
- The safeguarding and Wellbeing Subcommittee has been established to dissect, review, and record safeguarding and well-being matters, with minutes informing the full board.

This KPI has been met, and it is The Pollen Shops assessment that communication channels highlight the organisation's commitment to safe sport, for example:

• The Sport 80 membership system integrates a Safeguarding and Well-being feature accessible to the Welsh Gymnastics community. A dedicated "button" on every page for reporting concerns. This can significantly improve the speed and efficiency of addressing concerns, fostering a safer and more supportive environment.

- Launching a redesigned website with a specific page for policies and procedures is a strategic move towards transparency and accessibility. Making the Safeguarding and Wellbeing Policy easily accessible educates the gymnasts about their rights and the support available and underscores the organisation's commitment to these issues.
- The decision to include safeguarding and wellbeing highlights in every issue of Gym Mail, along with information about significant dates and external support agencies, is an effective way to keep the community informed and engaged.

# Review of KPIs about Safeguarding, concerns, and wellbeing

Welsh Gymnastics uses the most up-to-date safeguarding processes and procedures.

This KPI has been met. The significant underpinning safeguarding policy is now in place, and the year-one target has been exceeded and stands at an estimated 70%.

- New Safeguarding and Wellbeing Policy (December 2023)

  A policy agreed upon by the Board, aligning with statutory requirements to ensure the safety and wellbeing of all involved.
- New DBS Policy (October 2023)
  Introduced stricter requirements and expectations, including compulsory DBS checks for judges, support staff (e.g., physiotherapists, choreographers), and anyone in a position of trust or wearing a branded uniform.

#### New Performance Safeguarding Policies (November 2023)

As part of a home nation initiative, policies focusing on hydration, weighting of gymnasts, and academic education were launched to promote gymnasts' health and educational wellbeing.

#### • Welsh Gymnastics Case Management and Safeguarding Panels (October 2023)

New panels were launched to handle case management and safeguarding issues, ensuring thorough and specialised attention to any arising matters.

## New Codes of Conduct (October 2023)

Codes of conduct for coaches, gymnasts, and parents were launched, setting clear expectations and standards of behaviour to support a safe and positive environment. Gymnast ambassadors were involved in reviewing and structuring the codes of conduct.

## Review and Rewrite of Welsh Gymnastics Member Rules

A comprehensive review resulted in rewritten rules that focused on safeguarding and wellbeing.

# • Safeguarding Training Review

An evaluation of existing safeguarding training was performed, with the CEO approving funding for a rewrite of the training materials to enhance their effectiveness.

- Welsh Gymnastics has established regular forums where coaches, judges, and staff can engage directly with the Executive Directors of Safeguarding and Wellbeing, Development, and Performance. These sessions aim to facilitate open dialogue, exchange ideas, and address concerns within the sport.
- Recognising the importance of continuous feedback, Welsh Gymnastics encourages parents and gymnasts to share their insights and experiences via the organisation's web pages and gym mail. However, there's an acknowledgement that more efforts are needed to capture and respond to this feedback effectively.
- Codes of Conduct Development: Codes of Conduct benefited significantly from the consultation with Welsh Gymnastics Young Ambassadors. The ambassadors' constructive criticism shaped the codes for all members, demonstrating the value of including young people's perspectives in governance and policy-making.
- Parent Engagement in Performance Squads: Regular parent evening sessions for performance squads facilitate direct communication between parents and the organisation. These sessions are designed to share feedback, provide updates, and address parents' questions.

# Section 3: Safeguarding Key Performance Indicators for 2024/25 & 2024/25

The following Key Performance Indicators (KPIs) have been developed to help Welsh Gymnastics track the activity it is undertaking to deliver its Safe Sport Plan.

#### Why use KPIs?

KPIs evaluate performance against specific targets or benchmarks and provide an objective way to measure progress over time. In this case, a range of KPIs will be used to measure progress against the Safe Sport Plan.

By monitoring KPIs, Welsh Gymnastics can determine if the safeguarding measures set out in the Safe Sport Plan are having their intended impact. If they are not, or progress is slow, then Welsh Gymnastics can adjust activities as needed.

KPIs will be monitored by Welsh Gymnastics staff and will be reported individually or collectively within the Safe Sport Board Sub-group Highlight Report.

A full independent report on how Welsh Gymnastics is meeting its safeguarding KPIs will be published annually. This report will also update the KPIs if necessary.

By publishing KPIs and then tracking progress against them, Welsh Gymnastics will demonstrate its commitment to safeguarding. This will enhance the organisation's reputation and increase confidence among gymnasts, parents, and other stakeholders, including statutory bodies and funders, that the organisation is taking the issue of safeguarding seriously.
